GETTING YOU AWAY ON TIME

AT THE AIRPORT:



Please ensure you have completed check-in before the time indicated above. A passport is required for international travel, please check that your passport and any visas are valid. Air New Zealand does not require reconfirmation for our services, but on the day please check arrival and departure times online or call our flight arrivals/departures number.

BAGGAGE:



Checked bag allowance is 2 pieces each (Economy max combined weight is 46kg, Premium Economy/Business 64kg - with the exception of Premium Economy travel including flights on another airlines, where the Economy baggage allowance will apply on those flights). If you exceed this allowance, charges will apply. On Air New Zealand the maximum weight for any bag is 32kg. For specific details visit airnewzealand.com or operating airline website. On board you're allowed one bag per person or two bags for Premium Economy (see exception above) or Business (maximum 7kg each bag). Security restrictions apply to liquids, aerosols, gels and dangerous articles permitted onboard the aircraft. Any liquids, aerosols or gels must be in containers of 100ml volume or less and must fit in one re-sealable transparent plastic bag of 1 litre volume (approx 20cm by 20cm). Non-essential liquids should be packed in your checked-in baggage.

Customers transiting or entering the USA on the Non-immigrant Visa Waiver Programme should obtain an Electronic System for Travel Authorisation (ESTA) at least 72 hours before their departure date or earlier. Travel will not be permitted without an ESTA. For more details, or to apply, go to https://esta.cbp.dhs.gov/esta.

When you travel to the US (or spend more than 8 hours in the US while in transit to another country), you must provide your country of permanent residence. You must also include the street address where you will be staying in the US (including state and ZIP code) on your arrival form. This information is a pre-requisite to boarding your flight and can be given at any time up to and including check-in. Non-citizen, US permanent residents should give their Green Card number instead of their US address. US citizens are exempt from the address requirement.
